Office Order

Resource Pool development under Satat Jeevikoparjan Yojana

Keeping in the view the need for a differential, intensive strategy for sustainable livelihood opportunity for Ultra Poor households, the Govt. of Bihar has launched the Satat Jeevikoparjan Yojana. The yojana targets to cover 1,00,000 ultra-poor household through a customized ultra-poor graduation approach.

Under the yojana, ultra-poor households were endorsed in Village Organizations. For handholding, mentoring, coaching of endorsed households a dedicated Master Resource Person (MRP) for each 30-50 HHs have been identified and deployed at Panchayat level. After selection, various modular training were provided to the MRPs on different components of the program.

Confidence building is a very important tool under the capacity building component. The training of SJY households on "Confidence Building & Enterprise development" (CB & ED Training) is organized by the concerned districts for all eligible HHs. Household training under different component of SJY is a continuous process for all eligible Ultra Poor Household as required throughout the project period.

Keeping in the view to expedite the Capacity Building of VOs/ CLF, modular training MRPs and household level training under SJY, a dedicated resource pool of project staffs need to be identified & developed in all 38 Districts. For this the following project staffs will be deputed at DPCU under Satat Jeevikoparjan Yojana in their concern district. The deputation of the following staffs:-


Assignment / Task assigned during Deputation period:

1. Identification of 40-75 eligible CRPs per District and to develop them as a resource CRPs (through trainings) for ultra-poor households residential/non-residential training at District/Block levels.
2. Ensure training/refresher training of all endorsed household on Confidence Building & Enterprise development and Graduation Training as per project timeline under SJY.
3. Support District team to conduct MRP training /refresher training on different module under SJY.

4. To conduct training of community cadres, CBOs members, Procurement committee members on different processes of SJY like- Endorsement process, fund transfer process, productive asset transfer process , enterprise set-up process etc.
5. Any other SJY related task assigned by District or State SJY team.

Compensation and other directions:

1. Concern resource person should submit Monthly activity plan and report to District unit and State SJY team.
2. Performance appraisal of them to be done on the basic of assignment / task outlined in the office order. For performance appraisal 70% weightage to be given to the DPM and 30% to the SJY District Nodal.
3. Above mentioned project staff will be deputed for a period of one year or till further order whichever is earlier and they will be entitled for the facilitation allowance of Rs 4000/- per month.
4. They can claim the TA/DA for the official tour as per their entitlement. FLTA will not be admissible to them.
5. They should have their own Motorcycle/two wheeler within one Month of deputation.
6. Salary and other benefits will be paid from the concern DPCU.
7. Sitting place to be allotted from DPCU.
8. The office order will be effected from 1st April 2020.
