## OFFICE ORDER

BRLPS (JEEViKA) has made significant strides to provide timely capitalization (both from the project and the mainstream financial institutions). It has been a successful endeavor till now. However, much more is required to be done in order to make an impact both on qualitative and quantitative parameters. The current Financial Year (2020-2021) needs charting of the way stressing upon timely repayment along with timely capitalization, higher doses of disbursement, attempt to make a spade work for the Insurance, expanding Bank Sakhi Model, rolling out the interest subvention initiatives, stressing upon Community Finance works besides other responsibilities bestowed upon. The above-mentioned works become all the more important during the challenging time of COVID-19. The whole endeavor will require due dedicated effort along with possibility of improving upon the existing policies and embarking on the new ones as well as per the need.

Timely capitalization. Disbursement and Coverage under Insurance in FY 2019-20 had been possible with the incessant effort of the Block Team, District Team and SPMU Team. The effort of the SPMU team and District team got complemented with the presence of officials manning the "Help Desk" at SPMU. "Help Desk" at SPMU played pivot role in follow up from the districts/blocks/banks and in preparation of documents along with disbursement.

It has been in the interest of the project to utilize the services of people placed at SPMU as "Help Desk" in continued way for achieving significant result within the mentioned gamut. Based on the facts mentioned, approval has been accorded for the following aspects:

a) Approval has been accorded for the continuation of the services of Mr. Rajeev, Mr Arvind, Mr Sant, Mr Nand Lal and Mr Shambhu as Help Desk Team Member at SPMU. Mr Nand lal has been asked to operate presently from Buxar (his native place) during the COVID time. Buxar needed support as well to move to the next trajectory.

- b) HR Section has been directed to proceed further in terms of taking cognizance of the fact and doing proper communication with the DPCUs in light of Office Order no 724 dated 18/06/2020.
- c) As stipulated, the allowance provided has to be done away with from 1<sup>st</sup> July 2020 for the above-mentioned persons.
- disbursement, Insurance, timely capitalization from the project, Interest Subvention and other works important for the project occupies pivotal priority. It will be immensely important that monitoring and facilitation of these activities are galvanized through the "Help Desk Strategy". PC-FI has been delegated with responsibility to identify up to 15 persons from across the district/block to work with him on the issues mentioned above. The person concerned may be placed at DPCU/SPMU/Place outside the present place of posting to support the endeavor in better way. They will be over and above 5 people who are working at SPMU as "Help Desk Team Member".

The above-mentioned aspects have become important as PC-FI and SPM-BL had been provided with additional responsibility which required adequate time and attention.
