Office Order

BRLPS (Jeevika) intends to digitize the transaction of SHGs. This requires dedicated approach and adequate precaution as there is a lot of Legacy data (which is very crucial for portraying the credential of SHG member who have shown resilience to become preferred client of the banking system). These adequate data needs to be leveraged when the process of digitization is envisaged. This requires a dedicated approach, methodology and adequate follow up.

There is an opportunity to create scenario that of **Grameen-CIBIL**. This is primarily because lending to woman members directly has very limited portfolio with banks.

If the endeavours are taken as pilot basis to facilitate digitization of SHG transactions (along with the capturing of legacy data), it has the potential to mainstream the inclusion of the women members for individual lending as well. However this will require adequate policy advocacy and sensitization to difference stakeholders.

Grameen-CIBIL (Digitization and capturing of legacy data) has huge potential if nurtured in long-way. It will also support LokOS implementation in these Blocks as cut off data of all SHGs would be prepared for Digitisation process and ready data could be entered in LokOS as well. It will be also required to make LIVE data for 6 months, so that Gramin CIBIL for related members could be created with help of ongoing digitised payment.

Based on the facts mentioned above and the note written by PM-CF, approval has been given on the following:

- (a) Approval has been accorded for a budget of Rs. 29, 42, 250/- (Rs. Twenty Nine Lakhs and Forty Two Thousand & Two Hundred Fifty only) towards facilitating digitization of SHGs in 2 blocks of Patna. Initially, it will be applicable in Danapur block.
- (b) This will be booked under B 2 component of Institution & Capacity Building head under NRLM.
