Office Order

"To maintain financial Discipline while implementing Integrated Goat and Sheep Development "

JEEVIKA is implementing "Integrated Goat and Sheep Development Scheme" since FY 2016-17 in which 3 Breedable Black Bengal Goats are distributed to each selected households as per the target and fund provided by Department of Animal and Fisheries Resources, GoB.

Vide Office Order No: BRLPS/Proj-LS/463/13/621 dated 09.05.2023, guideline for implementing Integrated Goat and Sheep Development Scheme for FY 2022-23 has been issued. While implementation of the aforementioned scheme, non-adherence to the guidelines and instances of financial misappropriation has been observed at some of the implementation area. To ensure financial discipline throughout the implementation process, the District Project Coordination Unit (DPCU) and Block Project Implementation Unit (BPIU) are required to strictly adhere to the instructions outlined below:

- 1. The validation format (Part 1-3), as mentioned in **Annexure-1**, must be completed by the project staff after physical verification, as prescribed in the DBT Guideline circulated vide office order no: BRLPS/Proj-LS/463/13/Vol:2/4764 dated 05.03.2018.
- 2. During the Ear Tag Camp, the BPIU team shall conduct thorough verification of all members and their goats. The details of the verification process should be diligently recorded in the specified Books of Record. Additionally, it is mandatory to upload a photograph of each member with their goats on the E-Goatery Application
- 3. The District Project Manager (DPM) shall establish a committee comprising the Manager-Livestock, Procurement Manager, concerned Block Project Manager (BPM), and Block Mentor. This committee will be responsible for verifying a minimum of 10% of the beneficiaries within each Goat Producer Group after subsidy payment. Furthermore, the committee will ensure the accuracy of beneficiary details in the specified Books of Record and the Mobile Application. The verification format is provided in Annexure-2.

The implementation of the aforementioned scheme requires a process-oriented approach, with different levels of staff being responsible at each step. In the event of non-adherence to the guidelines stated in Office Order No: BRLPS/Proj-LS/463/13/621 dated 09.05.2023, or any instances of financial misappropriation, embezzlement, fraud, or similar irregularities during the scheme's implementation, the following project staff will be held accountable:

They will also oversee the documentation of physical and financial details in the specified Books of Record and ensure the timely updating of information in the E-Goatery Application.

This order shall come into effect immediately. All staff members are requested to adhere to these guidelines and execute their duties accordingly.
