OFFICE ORDER

Based on the above facts, following has been approved:


- 1- In the FY 2020-21, work around Interest Subvention, Financial Literacy, CLF Strengthening, higher doses of credit linkage, disbursement, insurance, timely capitalization and other works important for the project will occupy significant importance. It will be immensely important that monitoring and facilitation of these activities are galvanized through "Help Desk Strategy". As per the office order numbered BRLPS/Proj-FI/497/14/Vol-V/4997 dated 03rd March, 2020, PC-FI has been delegated with responsibility to identify up to 15 persons from across the district/block to work with the FI team on the issues mentioned above.
- 2- In this regard, **Mr. Shambhu Kumar, TO, Samastipur** has been identified and supporting the SPMU FI team on the process and work related to Interest Subvention from 16th march 2020 at SPMU. It will play pivotal role in follow up and support to districts/ blocks/ banks related to different FI aspects like Interest Subvention, Financial Literacy, preparation of documents along with disbursement and Repayment. Mr. Shambhu Kumar will continue working at SPMU as "Help Desk Team" member. His (Mr. Shambhu Kumar) presence at SPMU may be considered as tour to SPMU from **16th March 2020 to 31st March 2020** to support the process of Interest Subvention. Further, Mr. Shambhu Kumar has been allowed to be deputed as per norms to support the SPMU FI team on the above-mentioned aspects from **01st April 2020 to 30th September 2020**.

The above-mentioned official would be on deputation initial for a period of 06 months (01st April 2020 to 30th September 2020). During this period, they would be getting HRA at the rate applicable for State Capital. These officials would get salary for the period of deputation from respective districts of posting on basis of absentee sent by SPM-MF.
