Vide office order BRLPS/Project/166/10/3805 dated 08.10.2013 funds received from Department of Agriculture under National Food Security Mission (NFSM) alongwith own fund of BRLPS had been allocated to your districts for Community based procurement of Sprayers, Weeders and Diesel pumpsets. INSTRUCTIONS FOR BOOKING EXPENDITURE UNDER NFSM

- 1. 50% of Cono Weeder for SRI cost will be booked under NFSM and the remaining 50% cost will be booked under BRLP. Unit cost of cono weeder is Rs. 1500.
- 2. 50% of Knapsack Power Sprayer cost will be booked under NFSM and the remaining 50% cost will be booked under BRLP. Unit cost of Knapsack Power Sprayer is Rs. 6500. Rs. 3000 is to be booked under NFSM, rest amount under BRLP.
- 3. Rs. 10000/- of the Diesel Pump cost will be booked under NFSM and the remaining amount will be booked under BRLP. Unit cost of Diesel Pump including accessories is Rs. 35000. Rs. 10000/- will be booked under NFSM and remaining will be booked under BRLP.
