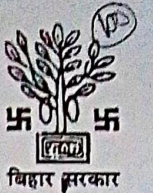



2. It should be ensured that the license should be issued in the name of the Village Organization, and not in the name of any member. However, the three office bearers of the Village Organizations will be the authorized signatories of the Village Organizations, who will be the official representatives in withdrawing and depositing money in BSFC account any of two will be authorized to sign the document.
3. Any official document or any official representation will be prepared in the name of the Village Organization and not in the name of the members.
4. On rotation basis all SHGs will be involved in the distribution activity; and not an individual member responsibility. Community run system should be encouraged to make the system run participatory, so that everyone can understand the operations.
5. It is proposed that in every Public Distribution System monthly meeting with the District Magistrate, a participation of the Community run PDS should be made compulsory. So that valuable feedback about the VO run PDS is shared.
6. It is anticipated that in one block more than 10 Fair Price Shops would be run by the Jeevika - VO's, hence, one specific day should be allotted for delivery of Kerosene oil and Food Grain. This will support the women team to plan properly in procurement and distribution both.

The aforementioned things should be taken care of by district, while issuing the license of the PDS to the Jeevika - Village Organizations.
