- b) Applicable GST must be clearly stated. All duties, taxes, freight, insurance, delivery charges and other levies payable by the contractor under the contract shall be included in the quoted price.
- c) The rates quoted by the bidder shall be fixed for the duration of the supply and shall not be subject to adjustment on any account.
- d) The Prices should be quoted in Indian Rupees only.
- e) Taxes will be deducted at source, if applicable.
- f) Service Tax in connection with the supply/service shall be shown separately.

6. Submission of Bids:

- a. A bidder shall submit only one quotation in a sealed envelope.
- b. The bidder must mention full detailed specification of the items quoted. Mere copying of the specifications mentioned by the purchaser or mentioning words like "complying"/"compliable" is not sufficient.
- c. Envelope containing bids must bear on the cover itself, name of item bidding for, name and full address with phone numbers of the bidder.
- d. Bidder has to submit the draft layout of the tableau along with their bid.

7. Validity of Quotation

Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission.

8. Evaluation of Quotations

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) Are properly signed; and
- (b) Conform to the terms and conditions, technical specifications and qualification criteria.

9. Award of Contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who in the assessment / judgment and sole discretion of the BRLPS, has technical and financial capability to execute the contract and has quoted the lowest price.

In case, if L1 agency fails to do the job, BRLPS may take the services of L2 agency and so on for completion of work and presentation of tableau on the occasion of Independence day i.e, 15th August 2022.

10.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotation, to cancel the bidding process and reject part/all quotations at any time prior to the award of contract.

Specification of Tableau to be presented on 15th August, 2022 at Gandhi Maidan, Patna.

Every year JEEViKA had demonstrated the Community Based Organization strength through Tableau on occasion of Republic Day and Independence Day programme

Tableau has always been a branding tool of communication for JEEViKA. JEEViKA will present the tableau on occasion of Independence Day 2022 at Gandhi Maidan, Patna with Subject of "महिला सशक्तीकरण". It is proposed to initiate the procurement for hiring of an agency for tableau preparation and live performance. The specification is mentioned as below: -

Height: 15 Feet Width: 11 Feet Length: 50 Feet

Entire work will be done on plywood, Plaster of Paris, Bamboo and other design material as per the design provided by BRLPS with creative art and sculpture/ Cutouts work having other materials with 3D and 4D effects with ply wood work. All design of front and back will be created with 4D and 3D effect with ply wood work as decided by BRLPS.

The tableau will have high power sound system with battery/ generator. All the sculpture work done by highly professional artist/holding BFA/MFA degree from reputed state/national institution. All fresh flower decoration work will be done by agency(Front facia border gardening and two side panel gardening only with fresh flower). Any other requirement to improve the concept and visual grandeur can be done along with professional photography of the complete tableau from all the angels hard and soft copy of at least 25 copies. The agency has to discuss with representative of BRLPS for finalization of design of tableau which may be changed accordingly to requirement of BRLPS.

Live performance through professional artist with costume. (25 professional artist and as per requirement).
