3. Technical Qualification Criteria

Fabrics

- a. Bidder should be a Board/registered weaver's cooperative society or any firm registered with Govt. of India/KVIC. Submit photocopy of registration certificate.
- b. Should have experience of supply of khadi clothes worth Rs. 75.0 lakh (cumulative order value in case of supply to more than one organization) in last financial year (i.e., 2023-24) to any government department/government organization/government body in the state of Bihar. Photocopy of purchase orders should be submitted.
- c. The bidder should have GST registration. Photocopy of GST registration certification should be attached.

d. The bidder should have PAN. Photocopy of same should be attached.

4. Bid Price

- a) Interlineations, corrections, erasures, and/or over-writings shall be valid only if initialed by the person or persons signing the bid.
- b) Applicable GST should be clearly stated. All duties, taxes, freight, insurance, delivery charges and other levies payable by the contractor under the contract shall be included in the quoted price.
- c) The rates quoted by the bidder shall be fixed for the duration of the supply and shall not be subject to adjustment on any account.
- d) The Prices should be quoted in Indian Rupees only.
- e) Tax will be deducted at source, if applicable.
- f) GST in connection with the sale shall be shown separately.
- g) Bidder must submit sample of quoted khadi fabrics having 1 feet x 1 feet size in the technical bid envelope.

5. Submission of Bids:

- a) Bid is to be submitted in two sealed envelopes. One envelope should contain technical bid and second envelope should contain financial bid. Both the envelopes should have the name of bidding firm. Both these envelopes then should be kept in one big envelope duly marked "Bid for supply of Khadi Fabrics" with the name and complete address of the bidding entity.
- b) A bidder shall submit only one bid in a sealed envelope.
- If a bidder submits its bid through post, postal delay will not be the responsibility of BRLPS.
- d) The bidder must mention full detailed specification of the items quoted.
- e) Envelope containing bids must bear on the cover itself, name of item bidding for, name and full address with phone numbers of the bidder.

6. Validity of Bid

Bid shall remain valid for a period not less than 90 days after the deadline date specified for submission.


7. Evaluation of Bids

- i. Technical Bids will be opened first.
- ii. Technical Evaluation of bids will be made first.
- Financial bids of only those bidders will be evaluated who will qualify in the technical evaluation.
- iv. Evaluation will be made item-wise.
- v. Evaluation will be made as per the provision of Bihar Financial Rules.

8. Award of Contract: -

- a. BRLPS may purchase the fabrics from other responsive bidders also on L1 rate.
- b. BRLPS will award the contract to the bidder whose bid has been determined to be substantially responsive and who in the assessment / judgment and sole discretion of the BRLPs, has technical capability to execute the contract and has quoted the lowest evaluated price.
- BRLPS reserves the right to decide the quantity of fabrics (of GSM & color) to be purchased.
- d. Successful bidder must submit Lab Test Report (based on the above specification) for the fabrics to be supplied before start of supply. The Lab should be certified from Government of India.
- e. Notwithstanding the above, BRLPS reserves the right to accept or reject any bids and to cancel the bidding process and reject part/all bids at any time prior to the award of contract.
- f. The bidder whose bid is accepted will be notified of the award of contract by the BRLPS prior to expiration of the bid validity period. The terms of the accepted offer shall be incorporated in the purchase order.
- g. BRLPS may increase or decrease the quantity as per requirement.

9. Quality Verification

- Quality of supplied fabrics may be verified either by a team of BRLPS officials or by a third-party agency as per the discretion of BRLPS official. Supplier has to inform in writing about its readiness to supply, so that quality may be verified.
- 10. Payment shall be made within 21 days (excluding Sundays and Holidays) after satisfactory delivery, quality and quantity verification. The supplier has to provide separate challans for each delivery which should be duly signed and stamped from the concerned office.
- 11. We look forward to receiving your bids and thank you for your interest in this project.
