

3. Eligibility Criteria

- Bidder should be authorized dealer/retailer of the Camera. Valid Dealership/Retailer ship certificate should be attached.
- b. Should be registered with GST. Signed photocopy of GST Certificate should be attached.
- c. Should have experience in supply of similar products. Supporting document should be attached.
- Catalogue of products should be attached.

4. Bid Price

- a) Interlineations, Corrections, erasures and/or over-writing shall be valid only if initialed by the person or persons signing the bid.
- b) All duties, taxes and other levies payable by the supplier shall be included in the total price.

- The Prices should be quoted in Indian Rupees only.
- d) Statutory deductions will be made at source, if applicable.
- e) GST in connection with the sale shall be shown separately.
- f) Bidder quote price for all items, otherwise their bid will be treated as non-responsive.
- g) The rates quoted by the bidder shall be fixed for the duration of the supply and shall not be subject to adjustment on any account.

5 . Submission of Bids:

- a) A bidder shall submit only one bid in a sealed envelope.
- b) Bidder should keep technical and financial proposal in two separate sealed envelopes. Both the sealed envelopes will be kept in one separate sealed envelope.
- c) Envelope containing bids must bear on the cover itself, name of item bidding for, name and full address with phone numbers of the bidder.
- d) The bidder should mention the detailed specification of the items quoted with make and/or model number. Mere copying of the specifications mentioned by the purchaser or mentioning words like "complying"/" compliable" is not sufficient.

6. Validity of Bid

Bid shall remain valid for a period not less than 90 days after the deadline date specified for submission.

7. Liquidated Damages (due to delay in supply):

The applicable rate is 0.07 % per day and the maximum deduction would be 5 % of the contract price. The liquidated damages, if any, shall be deducted from the invoice of supplier. On substantial delay in supply, purchase order may be cancelled.

8. Evaluation of Bids

The Purchaser will evaluate and compare the bids, determined to be substantially responsive i.e. which

- (a) Are properly signed; and
- (b) Conform to the terms and conditions, and specifications.
- (c) Has quoted for all the items mentioned above.
- (d) Has quoted the lowest evaluated total price.
- (e) All accessories should be compatible with camera, otherwise bid treated as non responsive.
- (f) If required, negotiation may be held with L1 bidder.
- 09. Award of Contract: The Purchaser will award the contract to the bidder whose bid has been determined to be substantially responsive and who has offered the lowest evaluated total bid price by adding the price of all line items
 - 9.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any bids and to cancel the bidding process and reject all bids at any time prior to the award of contract.
 - 9.2 The bidder whose bid is accepted will be notified of the award of contract by the purchaser prior to expiration of the bid validity period. The terms of the accepted offer shall be incorporated in the purchase order
 - 9.3 In case, if L1 agency fails to do the job, BRLPS may take purchase the items from L2 bidder on L1 rate.
- 10. Payment shall be made within 30 days after satisfactory delivery of the goods, successful demonstration and submission of invoices with challans.
