**3. Important Dates and Times/Bid Document**

- 3.1 Issuance of bid document : 30.11.2022  
3.2 Last date and time for Submission of bids : At 03.30 PM on 14.12.2022  
3.3 Date of opening of Bid : At 04.00 PM on 14.12.2022

**Note: Bidders may attend bid opening.**

**4. Eligibility Criteria**

- 4.1 GST registration number along with photocopy of certificate of registration.  
4.2 Photocopies of order with completion certificate for providing similar services have to be submitted.

**5. Bid Price**

- a) **The requirement of bandwidth may increase, if required.**  
b) The price shall be quoted for all the items strictly as described above and for full work including installation and commissioning.  
c) Interlineations, corrections, erasures and/or over writings shall be valid only if initialed by the persons or persons signing the bid.  
d) Applicable GST be clearly stated. All duties, taxes, freight, insurance, delivery charges and other levies payable by the contractor under the contract shall be included in the quoted price.  
d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.  
f) The Prices should be quoted in Indian Rupees only.  
g) Discount offered, if any, and conditions thereof must be clearly stated in the bid itself.  
h) Statutory deductions will be made at source, if applicable.

**6. All the installation & configuration of internet line, Fibre Terminator/Router/Connecting device will be provided and carried out by the service provider.**

7. **Warranty:** Bidder has to provide maintenance/guarantee/warranty of the service/items to be used in providing the service.

**8. Submission of Bids:**

- 8.1 A bidder shall submit quotations in **sealed envelope using their own stationery**. A bidder shall **not submit more than one quotation**.

- 8.2 **The bidder must mention the full detail specifications of the items quoted.** [Mere copying of the specifications mentioned by the purchaser or mentioning words like "complying"/"compliant" is not sufficient.] The bidder shall furnish, along with the offer, technical brochure supporting specifications of the offered item.

- 8.3 Envelope containing bids must bear, on the cover itself, name and full address of the bidder. Bid number and date & time of bid opening shall also be super-scribed on the cover.

- 8.4 **For bids submitted by post or courier, it is bidder's responsibility that bids reach the purchaser's office before the scheduled time of closure of submission of bids.**

**9. Validity Period of Quotation**

Quotation shall remain **valid for a period not less than 60 days** after the deadline date specified for submission.

## **10. Evaluation of Quotations**

- 10.1 The Purchaser will evaluate and compare the quotation as a whole determined to be substantially responsive i.e., which
- (a) Are properly signed;
  - (b) Conform to the terms and conditions, technical specifications and Eligibility criteria are submitted.
  - (c) Internet line may be transfer to different location if required (bidder has to quote charges for relocation) but it is not considered in evaluation.
- 10.2 Evaluation of bid shall be made for whole service for Fibre. For this purpose, all sub-items and accessories, if any, of an item will be taken together and considered as one item.
- 10.3 GST in connection with sale of goods/services shall be taken into account in evaluation.

## **11. Award of contract**

- 11.1 The Purchaser will award the contract to the bidder
- (i) whose quotation has been determined to be substantially responsive; and
  - (ii) who, in the assessment / judgment and sole discretion of the BRLPS, has technical and financial capability to execute the contract; and
  - (iii) who has quoted the lowest price for the whole work except the quote for transfer of internet line to different location in Patna.
  - (iv) In case L1 agency fails to commence the work on time or otherwise, the work may be awarded to L2 agency.
- 11.2 **Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotation, to reject quotations for some or all items and to cancel the bidding process at any time prior to the award of contract.**
- 11.3 The bidder must furnish all the necessary license/certificates/tax clearance certificates from concerned authorities for carrying normal manufacturing or trading business/ execution of similar projects.
- 11.4 Prior to expiration of the quotation-validity-period, the award of contract/contracts by the Purchaser will be notified to the bidder, whose offer has been accepted. The terms of the accepted offer/offers shall be incorporated in the contract agreement.
- 11.5 Initially the contract will be awarded for ONE YEAR which may be extended for further period subject to need of BRLPS, satisfactory service and mutual consent/negotiation of the parties.

## **12. Performance Security**

Successful bidder has to submit 10 % performance security in the form of Demand Draft /Bank Guarantee issued from a schedule bank valid till contract obligation, which will be returned after completion of contract.

## **13. Completion Period:**

The services must be made operational within the date specified in the bidding document. Delay in start of service may attract punitive deduction @ 0.5% week up to a maximum of 5% which may be deducted from ONE TIME CHARGES. On further delay, contract may be terminated.

- 14 SLA deduction will be calculated on monthly basis, One nodal staff have to be provider by bidder to resolve issues if required, Integration with LAN has to be done by bidder, Place of installation will be provided by BRLPS and Bidder may provide online portal for monitoring.

**15. Dispute Resolution**


The Purchaser and the Service Provider shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract. If, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the Purchaser or the Service Provider may give notice to the other party of its intention to commence arbitration. Arbitration proceedings shall be conducted in accordance with the laws of India. The arbitration shall be held in Patna and the language will be ENGLISH.

**16. Payment:**

Payment shall be made within 21 days (excluding Sundays and Holidays) after satisfactory installation with configuration and upon submission of bill/s along with installation certificate duly signed by IT section of BRLPS as per the following payment chart:

- (1) One Time Charges will be paid after successful installation and configuration;
- (2) Annual Recurring Charges will be paid in four installments. 1<sup>st</sup> installment will be paid along with one time charges.
- (3) Installation, commissioning and configuration have to be done by bidder and billing start date should be after successful installation and its verification by IT teams.
- (4) Billing period will be quarterly.
- (5) Bidder has to provide one time and recurring cost separately.
- (6) Proportionate amount will be deducted on account of outage (of previous month) as per SLA from running bills of next month.
