REQUEST FOR EXPRESSION OF INTEREST

Expression of Interest [EoI] For Hiring of CA Firms for Internal Audits of Head Office (SPMU) and Thirty Eighty Districts Offices (DPCUs) with its Block Offices (BPIUs) in Bihar Rural Livelihoods Promotion Society for the FY 2019-20

The Government of Bihar has received a credit from International Development Association in various currencies towards the cost of Bihar Transformative Development Project (BTDP) through Govt. of India and intends to apply a part of the proceeds of this credit to payment under the contract for hiring services of Chartered Accountants firms for Internal Audit of Bihar Rural Livelihoods Promotion Society (BRLPS) for the financial year 2019-20. BRLPS is also implementing LSBA, MKSP, NRETP, NRLM and various other NRLM sponsored projects across 534 blocks in 38 districts of Bihar. BRLPS has been designated as State Rural Livelihood Mission for rolling out National Rural Livelihoods Mission in the state

1. Internal Audit Assignment Packages

Interested CA Firms must provide required information substantiating that they have the required qualifications, relevant experience, availability of appropriate team and financial capability to perform the services under the indicated assignment.

2. Eligibility Criteria

Eligibility for submission of EoI proposal, subject to minimum requirements indicated there against, are as under:

3. Important Notes

- 3.1. Any firm not qualifying the eligibility criteria elaborated at clause 2 above with minimum requirements need not apply as their Expression of Interest [Eol] shall be summarily rejected.
- 3.2. An audit firm may submit the Eol for more than one assignment up to maximum of 03 assignments with indicated preference, but will be given only one assignment depending upon the ranking and among indicated preferences.
 - However, a single proposal with clear description of maximum 03 assignments under prescribed tabular format shall be sufficient to indicate the preference for assignments.
 - Further, this is to be noted that the audit firm having been shortlisted for more than one assignment shall be required to furnish a separate proposal with separate audit team for each assignment for which the Request for Proposal [RFP] will be issued to such shortlisted firm.
- 3.3. The selection of Internal Auditors will be as per consultant guidelines of the World Bank. Shortlisted firms will be asked to submit technical and financial proposal after short listing.
- 3.4. Information regarding fulfillment of short-listing criteria should be provided in tabular form together with the relevant supporting documents. Tabular form may be downloaded from the website www.brlp.in. Interested firm may obtain any further information during normal office hours from Monday to Saturday.
- 3.5. This assignment is for one year and may be extendable up to a maximum of two years on a yearly renewal basis based on performance and mutual consent of both parties on same terms and conditions including audit fees.
- 3.6. Any disciplinary action/pending cases ICAI/GoB/GoI over the firm/partner may be disqualified. A declaration is required to be submitted by the firm.
- 3.7. Expression of Interest with requisite documents should be submitted to the Chief Executive Officer, Bihar Rural Livelihoods Promotion Society (BRLPS), Patna at the address given above in a sealed envelope clearly superscripted as "Eol for Internal audit of BRLPS for the FY 2019-20". Submission of expression of interest without hard bound cover, page numbering, affixing seal of firm & signature of partner on each page of Eol documents shall be summarily rejected. Last Date for Submission of Expression of Interests [Eol] is 25th of March 2019 till 04:00 PM.
