2. Eligibility Criteria & Categories of PIAs:

Applicants (Captive Employment Category) must fulfil the eligibility criteria as outlined in Chapter 7: Skilling Agencies -Categories & Criteria of the DDU-GKY Guidelines 2.0.

3. The Appraisal of the proposals shall be carried out with the following conditions:

- The target will be allocated to the agencies that score the desired marks in the appraisal. In case the application is for more than the available target, the Agencies suited best to the needs of state may be given priority. The Project Approval Committee (PAC) of Bihar will decide the actual target to be given to the Agencies.

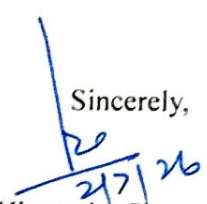
- All the proposed training should be completed before 31st December 2027 and placement initiation of all the candidates should be completed before 31st March 2028.

Late submissions will not be considered. Proposals deemed incomplete in any respect will be rejected outright.

Submission of an application does not guarantee the allocation of targets to the PIA.
