Assignment Title: **Hiring of Agency for Converting Training Materials in Digital Form.**

Bihar Rural Livelihoods Promotion Society, popularly known as JEEViKA, a registered society under the aegis of Rural Development Department, Government of Bihar marks a key chapter in rural development in Bihar. JEEViKA's journey of the last decade has coincided with the changing face of Bihar. Bihar Rural Livelihoods Promotion Society (BRLPS) was constituted by Govt. of Bihar as a special purpose vehicle to expedite the poverty alleviation interventions in the state. To sustain the project delivery mechanisms, Government of Bihar supported the initiative by leveraging financial resources from various multilateral agencies like World Bank and other national & state agencies. Over the last 10 years, JEEViKA has mobilized women from 1.27 Crore HHs into strong, sustainable and selfmanaged 10.34 Lakh Self-Help Groups (SHGs).

In pursuance to this, BRLPS intends to hire an Agency to **"For Converting Training Materials in Digital Form".** The Agency or the association of agencies will submit proposal in the closed envelope which will bear the name of the assignment for which EOI is being submitted.

Objective:

- To develop training materials in Digital form for effective Communication/ learning within community members and project staff.
- To develop animated content in a simple form which is easily understood by the community.
- To make learning interesting and catchy in the form of short films and videos such that it is easily perceived by community and easily remembered.
- To develop short clips of key messages which can be easily shared toreinforce behavioral change.

Scope of Work for Converting training materials into 2D/3D AnimationFilms (Digital Form):

- JEEViKA plans to hire creative production agency to convert the training materials into 2D animation films (05 films 3-4 minutes duration) and 3D animation films (05 films 3-4 minutes duration) on its several thematic verticals during the year 2021-2022. The exact number of animation films will be decided and communicated to the selected agency in due course.
- The agency will be provided a specific communication brief for each film to be developed, and will be required to submit a draft script, estimated length based on the film length, number of character and animation, and other special requirements.
- The agency should have access to the required hardware, software and other electronic equipment including editing and sound recording studio for production of high quality 2D and 3D animation films.
- Interested agencies are encouraged to apply by submitting links to their creative work/show reel, client testimonials and corporate capabilities in response to the specific requirements.

Process of completion of Task:

- > The entire implementation process may be captured.
- > Prepare printed transcripts of the narratives of all videos
- Consult BRLPS from time to time during the consultancy to ensure thatwork is on the right track. The agency may take references from project documents i.e., Flipchart, Training module and corporate brochure and Guideline

Deliverable:

Two master copies (Both mixed and unmixed) in DIGI Beta or DVC Pro Format. All Video-spots would be required to be submitted in suitable digital MPEG formatat broadcast quality for delivery by internet.

Schedule and Outputs

This assignment will be completed within one year. The extension and renewal of the contract would depend on the performance of the agency and their timely deliverable of the assignments.
