The aim of JEEViKA is to improve rural livelihood options and it works towards social and economic empowerment of the rural poor and women by promoting self-managed community institutions and further strengthening their livelihoods. Jeevika is promoting livelihoods of SHG members besides other interventions through livestock interventions like Goatery, Poultry, Dairy and Fisheries.
