The BRLPS is implementing Health, Nutrition & Sanitation services through Behaviour Change Communication (BCC) in all 38 districts of Bihar. - (ii) **Consultant AES & Plastic Waste Management** : The individual consultant will support in implementation of AES activities to create awareness for reducing and containing the spread of the AES and also work on plastic Waste Management to reduce the plastic waste, reuse & recycle the plastic waste generated in the rural area.
- (iii) **Consultant-Capacity Building-CRPs**: The Individual Consultant will provide Capacity building support to community Resource persons (CRPs) and conduct Exposure visits for other SRLMs to BRLPS.
