The Government of Bihar has received financing from the World Bank towards the cost of Bihar Transformative Development Project (BTDP) and intends to apply part of the proceeds for consulting services. The BTDP project will be implemented through Bihar Rural Livelihoods Promotion Society (BRLPS) for a period of 6 years. It is expected to cover around 60 lakh poor families spread over 300 blocks across 32 districts of Bihar under the project.

The purpose of this assignment is to develop, customize and maintain real time Decision Support System (DSS) for BRLPS for CBO MIS and its integration with ERP solution for HR, Procurement and Finance The business requirement of DSS-MIS would be to capture real-time and high quality data with validation of data and should be highly equipped and easy to use for data analysis (dashboards, Indicators based reports, tabular reports, alerts, maps, drill down reports etc.) which allows the user/management to use the data for day-to-day management and policy making of the project from SPMU to BPIU and other stakeholders and equally at Community Based Organizations (CBOs).
