Dear Mr. /Ms.:

1) Government of Bihar is implementing multiple projects funded by the World Bank & Govt of India through Bihar Rural Livelihoods Promotion Society (BRLPS). BRLPS has been set up by the GoB as part of its strategy to address rural poverty through enhancing the livelihoods of the poor.

The objective of the project known as "JEEViKA" is to improve livelihoods of the rural poor through social and economic mobilization and enable them to access credit, assets and services such as social safety nets from public and private sector agencies, including commercial banks. In order to work intensively with the target population and to demonstrate an effective and efficient model of project implementation for livelihoods development, the GoB has assigned the "Bihar Rural Livelihoods Promotion Society" (BRLPS) for implementing the Programme. Presently the project is operational in 534 blocks across all 38 Districts.

Centralized performance monitoring system (CPMS) for Rural Retail Shop and Didi ki Rasoi shall act as an integrated system to monitor the activities of these initiatives and shall not only record transactional information but shall also generate detailed reports in response to the input data for these initiatives. This shall offer owners and managers more insight into their business, allowing them to make actionable changes to increase revenue and cut costs.

Each Gramin Bazaar would be aggregating orders from almost 100 Kirana stores and place corresponding orders to the vendors. This facilitation will amount to a weekly transaction of at least Rs.1.00 lakh with 300 SKUs per Gramin Bazaar. The project intends to facilitate the opening of around 150 Gramin Bazaars and 50 Didi Ki Rasoi in next 12 months. The monitoring of these Gramin Bazaars and Didi Ki Rasoi is critical to determine their business sustainability.

2. Introduction	2.1 The Client named in the <b>Data Sheet</b> intends to select a Consultant from those listed in the Letter of Invitation, in accordance with the method of selection specified in the <b>Data Sheet</b> .
	2.2 The shortlisted Consultants are invited to submit a Technical Proposal and a Financial Proposal, or a Technical Proposal only, as specified in the <b>Data Sheet</b> , for consulting services required for the assignment named in the <b>Data Sheet</b> . The Proposal will be the basis for negotiating and ultimately signing the Contract with the selected Consultant.
	2.3 The Consultants should familiarize themselves with the local conditions and take them into account in preparing their Proposals; including attending a pre-proposal conference if one is specified in the <b>Data Sheet</b> . Attending any such pre-proposal conference is optional and is at the Consultants' expense.
	2.4 The Client will timely provide, at no cost to the Consultants, the inputs, relevant project data, and reports required for the preparation of the Consultant's Proposal as specified in the <b>Data Sheet</b> .
3. Conflict of Interest	3.1 The Consultants required to provide professional, objective, and impartial advice, at all times holding the Client's interests paramount, strictly avoiding conflicts with other assignments or its own corporate interests, and acting without any consideration for future work.
	3.2 The Consultant has an obligation to disclose to the Client any situation of actual or potential conflict that impacts its capacity to serve the best interest of its Client. Failure to disclose such situations may lead to the disqualification of the Consultant or the termination of its Contract and/or sanctions by the Bank.
	3.2.1 Without limitation on the generality of the foregoing, the Consultant shall not be hired under the circumstances set forth below:

7. General Considerations	7.1 In preparing the Proposal, the Consultant is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal.		
8. Cost of Preparation of Proposal	8.1 The Consultant shall bear all costs associated with the preparation and submission of its Proposal, and the Client shall not be responsible or liable for those costs, regardless of the conduct or outcome of the selection process. The Client is not bound to accept any proposal, and reserves the right to annul the selection process at any time prior to Contract award, without thereby incurring any liability to the Consultant.		
9. Language	9.1 The Proposal, as well as all correspondence and documents relating to the Proposal exchanged between the Consultant and the Client, shall be written in the language(s) specified in the <b>Data Sheet</b> .		
10. Documents Comprising the	10.1 The Proposal shall comprise the documents and forms listed in the <b>Data Sheet</b> .

	12.3 If it is established that any Key Expert nominated in the Consultant's Proposal was not available at the time of Proposal submission or was included in the Proposal without his/her confirmation, such Proposal shall be disqualified and rejected for further evaluation, and may be subject to sanctions in accordance with Clause 5 of this ITC.		
a. Extension of Validity Period	12.4 The Client will make its best effort to complete the negotiations within the proposal's validity period. However, should the need arise, the Client may request, in writing, all Consultants who submitted Proposals prior to the submission deadline to extend the Proposals' validity.		
	12.5 If the Consultant agrees to extend the validity of its Proposal, it shall		

	be done without any change in the original Proposal and with the confirmation of the availability of the Key Experts.
	12.6 The Consultant has the right to refuse to extend the validity of its Proposal in which case such Proposal will not be further evaluated.
b. Substitution of Key Experts at Validity Extension	12.7 If any of the Key Experts become unavailable for the extended validity period, the Consultant shall provide a written adequate justification and evidence satisfactory to the Client together with the substitution request. In such case, a replacement Key Expert shall have equal or better qualifications and experience than those of the originally proposed Key Expert. The technical evaluation score, however, will remain to be based on the evaluation of the CV of the original Key Expert.
	12.8 If the Consultant fails to provide a replacement Key Expert with equal or better qualifications, or if the provided reasons for the replacement or justification are unacceptable to the Client, such Proposal will be rejected with the prior Bank's no objection.
c. Sub- Contracting	12.9 The Consultant shall not subcontract the whole of the Services.
13. Clarification and Amendment of RFP	13.1 The Consultant may request a clarification of any part of the RFP during the period indicated in the <b>Data Sheet</b> before the Proposals' submission deadline. Any request for clarification must be sent in writing, or by standard electronic means, to the Client's address indicated in the <b>Data Sheet</b> . The Client will respond in writing, or by standard electronic means, and will send written copies of the response (including an explanation of the query but without identifying its source) to all shortlisted Consultants. Should the Client deem it necessary to amend the RFP as a result of a clarification, it shall do so following the procedure described below:
	13.1.1 At any time before the proposal submission deadline, the Client may amend the RFP by issuing an amendment in writing or by standard electronic means. The amendment shall be sent to all shortlisted Consultants and will be binding on them. The shortlisted Consultants shall acknowledge receipt of all amendments in writing.
	13.1.2If the amendment is substantial, the Client may extend the proposal submission deadline to give the shortlisted Consultants reasonable time to take an amendment into account in their Proposals.
	13.2 The Consultant may submit a modified Proposal or a modification to any part of it at any time prior to the proposal submission deadline. No modifications to the Technical or Financial Proposal shall be accepted after the deadline.
14. Preparation of Proposals –	14.1 While preparing the Proposal, the Consultant must give particular attention to the following:
Specific Considerations	14.1.1 If a shortlisted Consultant considers that it may enhance its expertise for the assignment by associating with other consultants in the form of a Joint Venture or as Sub- consultants, it may do so with either (a) non-shortlisted Consultant(s), or (b) shortlisted Consultants if permitted in the <b>Data Sheet</b> . In all such cases a shortlisted Consultant must obtain the written approval of the Client prior to the submission of the Proposal. When associating with non-

	15.2 Depending on the nature of the assignment, the Consultant is required to submit a Full Technical Proposal (FTP), or a Simplified Technical Proposal (STP) as indicated in the <b>Data Sheet</b> and using the Standard Forms provided in Section 3 of the RFP.

	17.2 An authorized representative of the Consultant shall sign the original submission letters in the required format for both the Technical Proposal and, if applicable, the Financial Proposal and shall initial all pages of both. The authorization shall be in the form of a written power of attorney attached to the Technical Proposal.
	17.2.1 A Proposal submitted by a Joint Venture shall be signed by all members so as to be legally binding on all members, or by an authorized representative who has a written power of attorney signed by each member's authorized representative.
	17.3 Any modifications, revisions, interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the Proposal.
	17.4 The signed Proposal shall be marked "ORIGINAL", and its copies marked "COPY" as appropriate. The number of copies is indicated in the <b>Data Sheet</b> . All copies shall be made from the signed original. If there are discrepancies between the original and the copies, the original shall prevail.

#### Appendix A.Financial Negotiations - Breakdown of Remuneration Rates

#### 1. Review of Remuneration Rates

- 1.1. The remuneration rates are made up of salary or a base fee, social costs, overheads, profit, and any premium or allowance that may be paid for assignments away from headquarters or a home office. An attached Sample Form can be used to provide a breakdown of rates.
- 1.2. If the RFP requests submission of a technical proposal only, the Sample Form is used by the selected Consultant to prepare for the negotiations of the Contract. If the RFP requests submission of the financial proposal, the Sample Form shall be completed and attached to the Financial Form-3. Agreed (at the negotiations) breakdown sheets shall form part of the negotiated Contract and included *in* its Appendix D or C.
- 1.3. At the negotiations the firm shall be prepared to disclose its audited financial statements for the last three years, to substantiate its rates, and accept that its proposed rates and other financial matters are subject to scrutiny. The Client is charged with the custody of government funds and is expected to exercise prudence in the expenditure of these funds.
- 1.4. Rate details are discussed below:
  - (i) <u>Salary</u> is the gross regular cash salary or fee paid to the individual in the firm's home office. It shall not contain any premium for work away from headquarters or bonus (except where these are included by law or government regulations).
  - (ii) <u>Bonuses</u> are normally paid out of profits. To avoid double counting, any bonuses shall not normally be included in the "Salary" and should be shown separately. Where the Consultant's accounting system is such that the percentages of social costs and overheads are based on total revenue, including bonuses, those percentages shall be adjusted downward accordingly. Where national policy requires that 13 months' pay be given for 12 months' work, the profit element need not be adjusted downward.   - (iii) <u>Social Charges</u> are the costs of non-monetary benefits and may include, inter alia, social security (including pension, medical, and life insurance costs) and the cost of a paid sick and/or annual leave. In this regard, a paid leave during public holidays or an annual leave taken during an assignment if no Expert's replacement has been provided is not considered social charges.
  - (iv) <u>Cost of Leave</u>. The principles of calculating the cost of total days leave per annum as a percentage of basic salary is normally calculated as follows:

Leave cost as percentage of salary =  $\frac{\text{total days leave x 100}}{[365 - w - ph - v - s]}$ Where w = weekends, ph = public holidays, v = vacation, and s = sick leave.

During negotiations, audited financial statements, certified

as correct by an independent auditor and supporting the last three years' overheads, shall be available for discussion, together with detailed lists of items making up the overheads and the percentage by which each relates to basic salary. The Client does not accept an add-on margin for social charges, overhead expenses, etc. for Experts who are not permanent employees of the Consultant. In such case, the Consultant shall be entitled only to administrative costs and a fee on the monthly payments charged for sub-contracted Experts.

- (vi) <u>Profit</u> is normally based on the sum of the Salary, Social costs, and Overheads. If any bonuses paid on a regular basis are listed, a corresponding reduction shall be made in the profit amount. Profit shall not be allowed on travel or any other reimbursable expenses.

#### 1. Background

#### 1.1 Gramin Bazaar: Concept

Owing to the large number of women owned Kirana stores operating with supply chain inefficiencies in Bihar, the Rural Retail Shop has been envisaged to address these inefficiencies through collectivization approach.

The rural retail Shop (RRS) is a community-based institution of rural Kirana store owners in a cluster/block that are brought under one unit. The brand name of the Rural retail Shop is Gramin Bazaar.

The *Gramin* Bazaar gives the rural retailers a platform for better bargaining power, a platform to share best retailing practices, reduce unit cost of purchase and unit cost of transportation. The *Gramin* Bazaar would give a better structure to the unorganized rural retail and act as an interface to push financial credit linkage, capacity building and training, create common infrastructure, transportation and an effective point of market linkage.

The *Gramin* Bazaar delivers following values to the retailers, consumers and producers/entrepreneurs:

- a) Aggregated orders
- b)Common transportation
- c) Retailing best practices

*Gramin* Bazaar is the nodal store to purchase, store and sell products to the rural retail association members while maintaining a margin for the sustainability of the store itself. *Gramin* Bazaars have the capacity to link directly with companies/ distributers and buy bulk items at source.

#### Didi ki Rasoi: Concept

The hygiene and quality of food served at canteens of government institutions such as hospitals, DM office etc. has been a cause of concern. Considering the significant number of customers served by these institutions' canteens at District and sub-divisional level, these establishments present a viable enterprise opportunity where women SHG members can participate. Hence, community members of JEEVIKA may propose to operate these canteens would provide high quality& hygienic food while earning gainful employment.

The objective of this initiative is to create an ecosystem where good food can be made available at fair prices, along with creating livelihoods for the community.

#### Institution's Objectives

- Hygienic canteens maintained in the institution's premises.
- High quality food made available to officers, staff, visitors etc.

#### JEEViKA Objectives

- Entrepreneurs would emerge from the community who would gain the skill of operating a high-quality for-profit unit.
- Canteens would act as a source of employment for the community members and additional income.

#### 2. Centralized Performance Monitoring System

Centralized performance monitoring system (CPMS) for Rural Retail Shop and Didi ki Rasoi shall act as an integrated system to monitor the activities of these initiatives and shall not only record transactional information but shall also generate detailed reports in response to the input data for these initiatives. This shall offer owners and managers more insight into their business, allowing them to make actionable changes to increase revenue and cut costs.

Each Gramin Bazaar would be aggregating orders from almost 100 Kirana stores and place corresponding orders to the vendors. This facilitation will amount to a weekly transaction of at least Rs.1.00 lakh with 300 SKUs per Gramin Bazaar. The project intends to facilitate the opening of around 150 Gramin Bazaars and 50 Didi Ki Rasoi in next 12 months. The monitoring of these Gramin Bazaars and Didi Ki Rasoi is critical to determine their business sustainability.

# Guidelines for Selection and Employment of Consultants under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, dated January 2011:

#### **"Fraud and Corruption**

1.23 It is the Bank's policy to require that Borrowers (including beneficiaries of Bank loans), consultants, and their agents (whether declared or not), sub-contractors, sub-consultants, service providers, or suppliers, and any personnel thereof, observe the highest standard of ethics during the selection and execution of Bank-financed contracts [footnote: In this context, any action taken by a consultant or any of its personnel, or its agents, or its sub-consultants, sub-contractors, services providers, suppliers, and/or their employees, to influence the selection process or contract execution for undue advantage is improper.].   - (iv) "coercive practices" is impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party<sup>10</sup>;
  - (v) "obstructive practice" is
    - (aa) deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from

- (b) will reject a proposal for award if it determines that the consultant recommended for award or any of its personnel, or its agents, or its sub-consultants, sub-contractors, services providers, suppliers, and/or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;
- (c) will declare mis-procurement and cancel the portion of the Loan allocated to a contract if it determines at any time that representatives of the Borrower or of a recipient of any part of the proceeds of the Loan were engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices during the selection process or the implementation of the contract in question, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur, including by failing to inform the Bank in a timely manner they knew of the practices;
