In order to ensure that economic gain, improvements made through livelihoods investments are not drained off, the project is increasing investment to improve access to food security, health, and nutrition and sanitation services to the poorest. The BRLPS is implementing Health, Nutrition & Sanitation services through Behaviour Change Communication (BCC) in all 38 districts of Bihar.
