Introduction:

Bihar Rural Livelihoods Promotion Society (BRLPS) an autonomous body the department of the Finance, Gov. of Bihar has been designated as state Rural Livelihoods Mission (SRLM) by the department of the Rural Development, Gov. of Bihar under the overall framework of the national rural Livelihoods Mission to scale up of the JEEViKA model of poverty alleviation throughout of the state of Bihar in phased manner. SRLM has been mandated to enable 1.25 crore Rural Poor and Poorest of the poor families of the Bihar to come out of the poverty with enhanced quality of life through mobilizing poor families into self-reliant institutions and promoting sustainable livelihoods as well strengthening services delivery mechanisms.

Objective:

To support the Project management team in strengthening Liaison with Banking Institutions and Bank Linkage, putting system around insurance and Risk mitigation and scale up Alternative Banking Channels.

Job Description:

The consultant has to ensure the following outputs in his area of activities:

- Work towards designing a model on pilot basis to facilitate community institutions take up the role of BC/BF/CSP of BC to ensure inclusion of the poorest in its fold.

- Working on designing the system which aids the process of integration between Community institutions and financial inclusion strategy of the mainstream banks through the alternate channel of banking like BC and BF.
- Implement the pilot taken on financial inclusion of the poorest through Community institutions in its totality to enhance banking foot prints in the remote areas as well.
- Work towards making system congenial for community institutions to take the role of Business Facilitator/ Business Correspondent/ Customer Service Provider of BC.
- Making the alternate banking channel run in a way to ensure profitability to the community institutions.
- Ensure inclusion of the poorest in both letter and spirit by ensuring account opening of the members and facilitating other transactions through alternate channels of banking.
- Working on policy level to facilitate opening of the SHG's accounts and its transactions on alternate platforms of banking.
- Working on end to end solution for utilizing the services of alternate banking for taking other services like old age pension, pension for differently enabled people, widow pension and similar other social entitlements from the government department.
- Implementation of pilot on financial inclusion for integrating the delivery of social entitlements to the deserving people.
- Lending a supporting hand towards ensuring account opening and bank credit linkage of the groups as and when required. This means works towards all the related forward and backward linkages to ensure facilitation of community institutions with mainstream financial institutions.
- Extend training to project staffs and community cadres on issues related to different facets of Micro Finance.
- To be prepared for extensive field visit for providing handhold support to BPIU and DPCU in dealing with core issues related to financial services and establishing models around Total Financial Inclusion.
- Any other work provided by the project from time to time.
